Minutes of the Ordinary Meeting of Germoe Parish Council held on Thursday January 10, 2008 at 7:00pm in Balwest Methodist Schoolroom.

#### 1 APOLOGIES FOR ABSENCE

Apologies for absence were received from CCCllr Robertson and Cllr Taylor.

## 2 CONFIRMATION OF MINUTES OF THE LAST MEETING

Cllr Geake proposed, Cllr Felstead seconded, all others in favour that, subject to the hand-written amendments, the minutes of the Ordinary Parish Meeting held on Thursday December 6, 2007 are a true record and the Chairman signed them as such.

#### 3 MATTERS ARISING AND NOT COVERED IN THIS AGENDA

There were no matters arising.

## 4 PUBLIC PARTICIPATION

Mr Ash said that he was present (as were all other members of the public) to make representations about the application for development at Bargess Croft: he stated that

- a replacement dwelling is required to be built on the same footprint as the existing building
- there is no valid reason why the replacement dwelling should be a two-storey building
- contrary to what has been stated in the application, the new dwelling would be highly visible
- the design of the proposed dwelling is not in sympathy with surrounding buildings
- the plans provide insufficient information and are inconsistent
- the photographs accompanying the application are not of Bargess Croft
- no mention has been made of the historical significance of the site
- there has been no wildlife assessment of the site
- there is no indication of the proposed landscaping
- the issue of mine waste and contaminated land has not been addressed

Whilst not unsympathetic to a replacement dwelling on the site, he asked the Parish Council to urge the Planning Committee to refuse permission for development as described in this application.

Mr Nicholls stated that the new application does not address the reasons for refusal of the previous application for development and for that reason alone should be turned down. He added that he is unhappy about the manner in which Planning Enforcement Officers have dealt with complaints about the recently constructed garage.

Noting that the statutory site notice had been defaced and moved to a point some way away from the proposed development, Mr Macloed stated that the changes to levels which have already been created will cause damage to roots of trees. He asserted (and was widely supported in his assertion) that there is a badgers' set close to the proposed dwelling.

## 5 COUNTY AND DISTRICT COUNCILLORS' COMMENTS

Speaking of the planning application for Bargess Croft, KDCllr Keeling noted the strength of feeling expressed at the meeting by members of the public and agreed to talk about it to the Planning Officer concerned. If he feels it appropriate, he will ask for the decision to be made by the Planning Committee rather than using delegated powers. He drew the attention of those present to the facility afforded to members of the public by Kerrier District Council to speak at Planning Committee meetings.

## KDCllr Mrs Jenkin reported that

- she is involved in Mining Heritage projects throughout the District
- she is a member of the Culture and Heritage Single Issue Panel whose brief is to advise on the best ways of delivering service. In particular it aims to draw attention to events which are taking place throughout Kerrier and to encourage better use of the Helston Museum
- she hopes to create an Open Spaces Single Issue Panel with the intention of ensuring that that a management plan is in place ready for the future
- Kerrier's intention is to make the Helston Sports Centre more of a focus for local clubs
- In future the RNLI will be shoulder the responsibility for beach safety throughout Kerrier and along the Helford river

## KDCllr Mrs Greenstreet reported that

- KDC has drafted press releases concerning the public's newly-granted entitlement to speak at Planning Committee meetings and the disposal of surplus sports' equipment
- she is a member of the Homeless Panel Review.

She also cited a number of projects recently brought to successful fruition by Kerrier District Council and said that the present uncertainty at Kerrier made life very difficult for Officers who continued to do their best for the public.

## 6 POLICE REPORT

WPC Butcher reported that since October there have been three reported crimes in the area: the theft of an oil tank and two burglaries (the offenders have been arrested and court proceedings are imminent). The PACT scheme is now underway and, as a result of the first (admittedly small) batch of concerns, Paul Wilkinson from Cornwall Highways will visit the area on Tuesday January 15, 2008 to discuss various issues and in particular the absence of a speed limit past the school. Speaking of this, WPC Butcher noted that Central Government recommends a 20mph limit outside schools

## 7 PROVISION OF A CEMETERY FOR USE WHEN ST GERMOE'S IS CLOSED

The Clerk reported that he had visited Kerrier Planning Department where an Officer had confirmed that she foresaw no problems with an application for a cemetery on field 7247. He further reported that he had received a letter from Mr Bryant, who had confirmed his willingness to sell the field for use as a cemetery. Mr Bryant had stated that a surveyor had valued the field for burial purposes at £14,000. Following discussion, it was agreed that Germoe Parish Council should write to Mr Bryant drawing attention to the fact that the field does not presently have planning permission for use as a burial ground and requesting reconsideration.

#### 8 FOOTPATHS, SIGNPOSTS, MAINTENANCE

The Clerk told members that he had reported both the dangerous stiles on footpaths 15 and 17 and the broken Public Bridleway sign at Badgers Holt. The response he had received from Cornwall Countryside Access on all these matters had not left him confident that repairs would be undertaken with any degree of urgency.

Councillors decided to ask Cornwall to add Whippers Lane, the southern half of Moors Lane and other lengths of the Gold network of paths to the cutting regime.

#### 9 PROJECTS WITHIN THE PARISH

## Planting of wild daffodil bulbs on open areas in the Parish

The Clerk reported that the Council's application to the Cornwall Bio-Diversity Improvement Grants committee for funding for this project has been rejected. He stated that he has now sourced 500 bulbs at a cost of just under £100.00 However, it was agreed that Germoe Parish Council should defer the project to a later date.

## Siting traditional fingerposts and boundary stones within the Parish

The Clerk reported that

- there is a possibility of Kerrier helping with the funding of the boundary welcoming stones. However, following discussion, it was agreed that Germoe Parish Council should defer this project to a later date.
- he has no further news about the fingerposts.

# 10 PLANNING (this item was discussed following item 5 County and District Councillors' Comments) Applications

PA07/01969/F Mr M Berryman – Erection of a replacement dwelling and installation of a septic tank – Bargess Croft, Lower Balwest. Cllr Geake proposed, Cllr Mrs Clarke seconded, all others in favour to return this application with the following observations:

"Germoe Parish Councillors are disappointed that the essence of their comments on the earlier application for this site appears to have been disregarded by the applicant.

If the Planning Officer is minded to approve permission for this development, Germoe Parish Councillors request that it goes before the full Planning Committee.

If planning permission for development is granted Germoe Parish Councillors make a strong recommendation that a legal agreement is required from the applicant to the effect that the existing buildings will be removed and that the site will be reserved for a single dwelling. Furthermore, before building commences, Germoe Parish Councillors request that full surveys are made both of archaeological remains and wild life habitat.

Nevertheless, Germoe Parish Councillors urge the Planning Committee to refuse permission for this development on the grounds of its bulk, design, appearance and prominent setting within the landscape (which is adverse to visual amenities and within both the area of the World Heritage Site and an area of Great Landscape Value). Germoe Parish Councillors further note that the proposed site has the potential to prejudice historic mining artefacts and wild life.

Germoe Parish Councillors note that there is strong public feeling against this application."
