Cllr Blencowe proposed, Cllr Mrs Praed seconded all in favour to insure Germoe Parish Council through Aviva and to pay the premium demanded of £276.49.

Members noted that Germoe Parish Council will self-insure all its assets other than the War Memorial and the noticeboards at Great Work, Germoe Churchtown, Bal West and Nevada House during the year to May 31, 2017.

#### 18 FINANCE

The Clerk presented Councillors with a statement of Germoe Parish Council's financial position as at May 5, 2016. A copy of that statement is attached to these minutes.

Members considered a request from St Germoe PCC for financial help towards the maintenance of the churchyard. Cllr Blencowe proposed, Cllr Mrs Doeser seconded all others in favour, that the sum of £300.00 should be forwarded to St Germoe PCC (Section 214(6) of the Local Government Act 1972).

Parish Councillors considered the Statement of Assurance required for the Annual Return for the year ended March 31, 2016. Cllr Blencowe proposed, Cllr Taylor seconded, all others in favour that Germoe Parish Council should answer "Yes" to each of the questions posed by the Statement of Assurance which forms part of the Annual Return for the year ended March 31, 2015.

The Clerk reported that Mr Peter Richards, Germoe Parish Council's Internal Auditor, has signed off the Annual Return for the year to March 31, 2016 making no comments, observations or suggestions.
