Minutes of the Ordinary Meeting of Germoe Parish Council held on Thursday October 7, 2010 at 7:00pm in Balwest Methodist Schoolroom.

#### 1 APOLOGIES FOR ABSENCE

Cllr Geake and PC Vaughan sent their apologies for absence.

## 2 DECLARATIONS OF INTEREST

## 3 CONFIRMATION OF MINUTES OF THE LAST MEETING

Cllr Mrs Doeser proposed, Cllr Blencowe seconded, Cllr Taylor being absent from the last meeting abstained, all others in favour that with the addition of the hand-written amendment, the minutes of the Meeting held on Thursday September 2, 2010 are a true record and the Chairman signed them as such.

## 4 MATTERS ARISING AND NOT COVERED IN THIS AGENDA

Members noted that Mr Johnson is mistaken in his belief that he does not require planning permission to fell either the fig tree or the sycamore tree as reported in paragraph 5 of the minutes of the last meeting.

The Chairman proposed and it was agreed to alter the order of the agenda to allow PCSO Bell to report at this point.

#### 7 POLICE REPORT

PCSO Bell reported that no crimes had been reported to the Police in September 2010, which compares to two crimes reported during the same period in 2009. Speaking of Hallowe'en later in the month, he urged children and their parents to be aware that different peoples' perception of fun differs.

## 5 PUBLIC PARTICIPATION

Mrs Carroll stated that she had attended simply to present her case for the conversion and extension of barns in Higher Lane. She added that, following advice from Mr Martin Jose (Cornwall Council's Planning Officer), she had revised the original drawings and that he had intimated that he would support her application.

## 8 PARISH MATTERS

#### **Winter Service Provision**

Further to Cornwall Council's new policy concerning the provision and maintenance of salt bins, the Clerk reported that Mr Paul Liddicoat will charge £50 to store and spread when and where necessary one tonne of road

salt. Cllr Ross proposed, Cllr Mrs Clarke seconded all in favour to purchase one tonne of road salt to be stored in Mr Paul Liddicoat's charge and spread by him when and where necessary on the instructions of the Council.

## **Parish Design Statement**

Principally because of the present uncertainty in Local Government, it was noted that the Parish Council is still no further forward with this project.

### 9 PARISH COUNCIL MATTERS

Members considered the co-option of a Parish Councillor and agreed to advertise the vacant position on the parish noticeboards.

Members considered whether or not Councillors' out-of-pocket expenses should be reimbursed from public funds. Following discussion (during the course of which it was noted that the move towards localism means that individual Councillors are increasingly being asked to attend training sessions or to represent the Parish at meetings) it was agreed that the Clerk should draw up a proposal outlining when and how Councillors may be reimbursed and that this will be debated further at the meeting in November.

- a series of 'road shows' has been arranged to allow rate-payers to express their views on what should and should not be cut
- planning permission for the development of the Cornwall Motel site has been granted subject to a number of restrictions particularly those concerning light pollution and the accidental discharge of foul water into the fishing lake at Wheal Grey

#### 13 MEMBERS' QUESTIONS

Cllr Mrs Doeser presented members with a written report of the meeting concerned with the "Provision of real Affordable Housing" organised by the Helston and the Lizard Community Network which she had attended. This meeting examined Cornwall Council's Draft Affordable Housing Development Plan, which, in brief, includes innovative policies aimed specifically at smaller settlements and at sustaining the future of rural areas. More specifically it proposes

- that affordable housing should meet local community needs (two families in Germoe have been identified as being in need of affordable housing)
- to maximise the provision of affordable housing both for rent and for purchase
- new approaches to exception sites in rural areas
- that new development in communities where second homes make up more than 10% of housing stock must be for principal residences
- that developments with local support that meet local needs should be approved

The meeting had been told that access to mortgages is difficult for those on low income and that mortgage companies are unwilling to lend money for the purchase of affordable housing with an S106 agreement which limits subsequent sale on the open market

Members noted that the consultation period finishes on November 29

Cllr Mrs Doeser drew members' attention to the Calor Gas rural fuel poverty project (which highlights the complexities associated with living off-mains gas in Great Britain) and the stall which has been taken to advertise it at the Helston Farmers' Market on Saturday November 6, 2010
