Minutes of the Annual Meeting of Germoe Parish Council held on Thursday May 5, 2011 following the Annual Parish Meeting in Balwest Methodist Schoolroom.

# 1 ELECTION OF CHAIRMAN

Cllr Ross proposed, Cllr Mrs Clarke seconded, all others in favour that Cllr Sid Geake be elected to the Chair of Germoe Parish Council for the year 2011 - 2012.

# 2 CHAIRMAN'S DECLARATION OF ACCEPTANCE OF OFFICE

Cllr Geake read aloud and signed the statutory Declaration of Acceptance of the Office of Chairman of Germoe Parish Council for the year 2011 - 2012 in the presence of the Clerk and the Council.

# 3 APOLOGIES FOR ABSENCE

Apologies were received from Cllr Mrs Doeser.

# 4 DECLARATIONS OF INTEREST

There were no declarations of interest in items on the agenda.

There were no declarations of gifts (received as a result of being a member of the Council) of a value greater than £25

#### 5 CONFIRMATION OF MINUTES OF PREVIOUS MEETING

Cllr Ross proposed, Cllr Blencowe seconded, all others in favour that, with the addition of the hand-written amendment, the minutes of the meeting held on Thursday April 7, 2011 are a true record and the Chairman signed them as such.

#### 6 MATTERS ARISING AND NOT COVERED ELSEWHERE ON THIS AGENDA

It was noted that a hedge has been planted at Tresheba, Main Road, but that a gap has been left to allow users of the footpath 17 to exercise their rights. It was further noted that the stile at the western end of this footpath would benefit from a post to help users up and over the hedge.

# 7 PUBLIC PARTICIPATION

There were no members of the public present.

#### 8 CORNWALL COUNCILLOR'S COMMENTS

CCllr Keeling thanked members for the warm welcome he invariably receives at meetings of Germoe Parish Council and reported that the last twelve months have been some of the toughest experienced by local government. During the year

- the cuts and changes to the way in which Local Authorities are funded had resulted in a drop in funding from Central Government of some £56 million
- he had been particularly disappointed by the loss of funding for the proposed new Isles of Scilly link and described it as a blow both for the people of the islands and for the future prosperity of Penzance
- the widely publicised Ofsted report describing children's services as 'Inadequate' is being addressed

- community engagement with the Council had been short-listed as being one of the most improved services in the country
- a Local Enterprise Partnership has been established
- Arts Council funding for Cornwall's cultural programme was increased by 17%
- the 'Smarties' awards scheme had been introduced: the first awards were made to members of staff and to Cormac (for their sterling efforts in dealing with the snow and ice during last winter)
- funding from the People's Millions Big Lottery Fund has enabled the *Furry Café* in Helston to open its doors to young people
- the South West Regional Development Agency will be replaced by Locality Teams by March 2012
- the end of the year leaves Cornwall Council in good shape financially. Providing efficiency savings are achieved, essential frontline services should be maintained.

#### More recently

- he had discussed a number of local issues (such as road signs, hedge trimming, road conditions including potholes and additional warning signs for dangerous corners) with the Cormac team
- this discussion had included a suggestion that a list of local landowners whose land fronts the highway might be drawn up, in order that Cornwall Highways may remind them of their responsibility for ensuring their hedgerows do not encroach upon the highway
- he is awaiting a list of prices for the work he has asked to be done. This work includes speed signs, a Vehicle Activated Sign and associated sockets sited around the area (these will enable the VAS to be moved around).

# 9 POLICE REPORT

PCSO Sadler reported that there had been no crimes notified to the police in the month of April: three crimes had been reported in the same period last year.

PCSO Sadler warned members and residents alike that at this time of year there is an increase in thefts from gardens. She urged everyone to be vigilant and to report anything suspicious immediately.

The major restructure of the Devon and Cornwall Constabulary means that, although PC Vaughan will remain the Neighbourhood Beat Manager, he may find it difficult to attend meetings. PCSO Sadler will maintain the vital link between the Parish Council and the Police

# 10 ELECTION OF VICE-CHAIRMAN

Cllr Geake proposed, Cllr Taylor seconded, all others in favour that Cllr Blencowe be elected to be Vice-Chairman of Germoe Parish Council for the year 2011 - 2012.

Cllr Ross proposed, Cllr Mrs Clarke seconded all others in favour that Germoe Parish Council should re-adopt Standing Orders as last substantially revised in April 2006.

#### 12 FINANCIAL REGULATIONS

Cllr Ross proposed, Cllr Blencowe seconded all others in favour that Germoe Parish Council should re-adopt Financial Regulations as last substantially revised in April 2006.

# Helston and the Lizard Peninsula Community Network Panel

It was agreed that Cllr Mrs Doeser should continue to represent Germoe Parish Council at meetings of the Helston and the Lizard Peninsula Community Network Panel.

#### 14 PARISH MATTERS

Members noted that seventy-six replies to Germoe Parish Council's Local Needs Affordable Housing Survey have been received. These demonstrate support for the building of scattered units of Local Needs Affordable homes within the Parish. The completed questionnaires will now be passed to Cornwall Council for detailed evaluation.

CCllr Keeling reported that two chevrons will be sited at the Boscreege junction to warn motorists coming from both directions of the bend in the road.

The Clerk reported that, despite application to the Land Registry, ownership of Moors Lane remains unclear.

Cllr Blencowe proposed, Cllr Ross seconded all in favour that Germoe Parish Council should self-insure all assets other than the War Memorial for the year to June 1, 2012.

### 20 MEMBERS' QUESTIONS

Cllr Blencowe presented a report from Mr Berwick drawing members' attention to an outbreak of phytophthora on Rhododendron ponticum and bilberry populations on Tregonning Hill. Following advice from Cornwall Council and the Food Environment Research Agency, Mr Berwick has cut down and treated the affected plants which are growing on his land. It was agreed to thank Mr Berwick for undertaking this work and to write to FERA expressing Germoe Parish Council's disappointment at the lack of information concerning the project work being undertaken on Tregonning Hill. Cllr Blencowe agreed to monitor the situation on behalf of Germoe Parish Council.
